- 3. LInX Update
 - Sue Schmit: Setting up a national call-in for early November during the virtual IACP
 - NCIS is looking at 2021 budget to determine ability to integrate more CISC agency data into LInX
 - Any agencies who want/need training, let CM Shipley and/or Sue Schmit know
- 4. 2019 CISC Audit with Jim Pauley:
 - Thanks to CM Shipley and Katherine for their assistance, the audit went very smoothly.
 - Audit report No issues or exceptions noted. No signs of fraud.
 - Management analysis (required reporting) prepared by CM Shipley and reviewed by Feis & Co. that provides an overview of the CISC and its future.
 - Notes on financial statements that provide additional info about the CISC, financial statements, and reporting framework that is required for governmental entities

- COVID-19 disclosure potential negative impact on membership agencies
- Material weakness/significant weakness in management letter: discussed previously, centered around small staff and one salaried employee. The internal controls of the CISC balance the staff size. Chief Creager asks for recommendations on how to respond to this critique. Mr. Pauley doesn't need a written response, but it could be helpful to outline the procedures for reviewing financials which the board has. Commander Acosta will submit a letter outlining these procedures.

 - i. Update on Movement within Lexis Nexis newest primary contact, Mr. Joe Houston.
 - ii. Facial Recognition Update
- Worker's Compensation Insurance coverage: CIRSA or Pinnacol
 - i. Motion to proceed with insurance coverage with Pinnacol made by Chief Line, second by Chris Andrist. Unanimous vote, motion carried.
- MaiVERIC Pilot (Lakewood/Edgewater/JeffCo) "EYE WITNESS"
 - i. Question: Will the CISC Board allow CM Shipley to send a copy of all RDW data to MaiVERIC so they can filter out all except Mug shot data for purposes of completing a test pilot Facial Recognition effectiveness program? MaiVERIC would allow a third party to audit and confirm the unnecessary data is removed if desired.
 - ii. Decision after discussion: Individual agency downloads only, not the entirety of CISC RDW mug shot data. Need more information and review before determining a CISC path regarding the facial recognition process.
 - iii. Director Ken Evans suggested identifying some kind of public education regarding the need for this kind of data and/or policies. The IACP CJIS Committee is working on publishing just such a document and the CISC has posted a model policy for FR technology use on the CISC website.
